

## TALK TO A LAWYER DAY 2012

As a tribute to Rev. Dr. Martin Luther King Jr., District 6 works with the State Bar and Pro Bono Commission to sponsor “Talk to a Lawyer Day,” on **Monday, January 16th, 2012**. The program is an opportunity for attorneys statewide to offer free legal consultations to members of the general public who might not otherwise be able to afford the counsel of an attorney.

Locations will include sites at the Mounds Mall in Anderson, the Five Points Mall in Marion, the District 6 office in New Castle, and the Muncie Mall in Muncie.

If you are new to pro bono work, this is a great event. Attorneys volunteer for a two-hour block. During that time, they meet individuals for 10-15 minute counseling sessions to answer basic questions.
